2. DESCRIPTION AND FIELD OF APPLICATION

BK-Wood Effect Extra is a product used for forming of shapes with the rubber mould without sticking of BK-Wood Effect decorative mineral mortar for the mould during the process of work.

3. COMPOSITION

Chemical composition: water based emulsion

4. OTHER CHARACTERISTICS

Appearance: colourless transparent liquid

Density, kg/dm3: ~1,03

Consumption: App. 0.1 l/m² of the finished mortar structure

5. PREPARATION AND APPLICATION

BK-Wood Effect Extra is applied undiluted to the rubber mould in order to provide easy detaching from BK-Wood Effect decorative mortar during the process of modelling the wooden board structure. BK-Wood Effect Extra is applied to the rubber mould undiluted, with the brush. After each impression, new layer is evenly applied. If needed, remove residuals of decorative mortar from the mould. Lack or insufficient quantity of product might result in sticking of the mould for mortar, pulling out of the mass and poor final results.

Application temperature: the temperature of air and base during the installation

should be from +5 °C to +30 °C. Avoid direct sunlight, fog, wind and rain.

6. TOOL CLEANING

Tools should be thoroughly cleaned and washed with water immediately after use. If the tool is not washed immediately after use, hardened residuals should be mechanically removed.

7. HANDLING AND STORING

Proper use does not require any particular safety measures. Keep out of reach of children.

Product expiry and storing: 18 months in originally closed packaging. Store at the temperature from +5°C to +25°C, in a dry and aired room. Avoid direct sunlight and heat. Production date printed at the packaging.

8. INFORMATION ON REGULATIONS
